Top most excerpt from the UAP Bylaws, one of the main purposes and objectives of creating a Chapter is to be a extension of the national organization in the Chapter's territory or jurisdiction.1 Chapters are expected to implement and carry out all programs of the national organization, except when the nature of the project requires direct implementation by the national organization. 2 Chapters outside the country may be allowed to organize provided that they are composed of registered and licensed architects in the Philippines practicing architecture in the country where they have established residency. 3 Given the foregoing, it is essential that members, and even officers, of UAP chapters organized abroad must comply with the requisites that they are practicing architecture in the country where the chapter holds jurisdiction and are likewise residing in the same. Note that chapter organization is not limited to mere formation of chapter, but also includes governance, 4 i.e. administration and operation;

Secondly, for an officer to be qualified prior to election to his respective position, he must have actively participated in the affairs of the chapter for at least two (2) years. These affairs include but are not limited to attendance to and participation in chapter meetings 5, membership and involvement to Chapter Committees, i.e. Committee on Internal Affairs, Professional Practice, Governmental and External Affairs, Education, Professional Development, and Filipino Architecture, and taking part in programs and projects of the chapter. No member may arbitrarily or capriciously run for office without having himself immersed in the affairs and concerns of the chapter for a considerable period of time, i.e. two (2) years. Leading a chapter requires familiarity and understanding of the organization's, as well as the membership's, interests and welfares.

Thirdly, a nominee for Chapter President, when elected to office, shall be required to exercise general supervision over all the affairs of the chapter, preside over all meetings of the chapter board of directors and the chapter general membership,7 supervise all chapter committee works, social and business affairs,8 sign contracts, directives and legal instruments,9 and represent the chapter on all occasions and in all matters where it should be represented.10 All these duties and responsibilities of a Chapter President require physical attendance and presence, for purposes of efficiency, practicality, and productivity. It defeats the very purpose of organizing chapters outside the Philippines if any member not practicing and residing therein may be nominated and elected as an officer of the said chapter. The general membership of the chapter abroad needs actual representation in all matters and in all times. Lastly, notwithstanding the foregoing, the Chapter is given a wide latitude of discretion in all its affairs, provided that it shall not directly or indirectly nullify or contravene any provisions of the Articles of Incorporation and BOD regular meeting, as recorded by the Secretariat; and,

The above notes with merit to validate the resolution to enlighten that all members that outside Doha, Qatar will not be qualified to vote and nominated as stated thereof that it is essential that members, and even officers, of UAP chapters organized abroad must comply with the requisites that they are practicing architecture in the country where the chapter holds jurisdiction and are likewise residing in the same. Note that chapter organization is not limited to mere formation of chapter, but also includes governance,4 i.e. administration and operation and shall be required to exercise general supervision over all the affairs of the chapter to attends meetings of the chapter board of directors and the chapter general membership, chapter committee works, social and business affairs, in all matters where it should be represented.10 All these duties and responsibilities require physical attendance and presence, for purposes of efficiency, practicality, and productivity that requires a physical attendance and presence, for purposes of efficiency. It defeats the very purpose of organizing chapters outside the Philippines if any member not practicing and residing therein may be nominated and elected as an officer of the said chapter. The general membership of the chapter abroad needs actual representation in all matters and in all times. To become a good and active outstanding member it is a prerequisite to participate actively to a minimum 2 years in any events or the programs of the Chapter activities yearly with ethical conduct demonstrate the good behavior with professionalism to performs his/her duties as being officiated and oath as stipulated in bylaws. Comelec and Committee on Nominations shall prepare a reset of nomination and voters list as prescribed guidelines of UAPBylaws.
