CHAPTER BOARD RESOLUTION NO.002 S.2024

DELIBERATED & APPROVED BY THE CHAPTER BOARD OF DIRECTORS ON ITS

EXECUTIVE MEETING HELD ON SEPTEMBER 28 2023.

- WHEREAS we, the UAP Qatar Chapter also known as UAP Qatar LLC(G) Chapter Board of Directors, during the executive meeting held on September 28, 2023, agreed to establish and organize a Free Special Professional Licensure Examination (SPLE) review program; and
- WHEREAS during the said meeting, the chapter officers unanimously voted in favor of initiating this Free Special Professional Licensure Examination (SPLE) review program; and
- WHEREAS the purpose of this program is to provide support to aspiring architects, particularly targeting UAPGA (United Architects of the Philippines Graduate Auxiliary) members; and
- WHEREAS the United Architects of the Philippines Graduate Auxiliary (UAPGA), the duly recognized graduate arm of the United Architects of the Philippines (UAP), caters to architecture graduates and acts as a bridge for the aspirants to become registered and licensed architects;
- WHEREAS this program also serves as a corporate social responsibility (CSR) initiative, demonstrating the chapter's commitment to giving back to the community and supporting the professional growth of architecture graduates who are members of UAPGA; and
- WHEREAS the program will be facilitated by an SPLE committee comprising newly passed architects (who benefited from the program), voluntary members, mentors, facilitators, and the chairman of the UAP Qatar chapter dedicated to serving aspiring architects who are among the overseas Filipino workers in Qatar;
- WHEREAS there is a need to establish a formal structure for the administration of the Free SPLE Review Program;
- WHEREAS the establishment of an SPLE Committee is deemed necessary to oversee and manage the program effectively;
- WHEREAS the UAP By Laws 2009 Article 7 acknowledges the existence of the Commission on Education, under which Section 5 defines the functions of the Committee on Graduate Auxiliary, promoting the organization of

- WHEREAS in accordance with the aforementioned bylaws, the SPLE Committee shall also be known as the Committee on Graduate Auxiliary, thus aligning its objectives with those of the UAP's apprenticeship and educational initiatives;
- WHEREAS it is imperative to ensure the commitment of faculty volunteers, who will also serve as mentors, to fulfill their selfless service without any remuneration;
- WHEREAS any decisions that may occur, or any requirements, procedural processes, rules, and regulations endorsed by the Chairman, shall be approved by the executive board of the UAP Qatar chapter;
- WHEREAS the SPLE Committee, in coordination with the executive board, will organize a proper venue, mentors, facilitators, schedule, review materials, operational expenses and assist the aspirants without financial obligation;
- WHEREAS this board resolution is intended to be effective and applied yearly by the SPLE Committee in coordination with the executive board of the UAP Qatar chapter whenever the Special Professional Licensure Examination is scheduled through the announcement of the Philippine Professional Organization Qatar (PPO-Q);
- WHEREAS it is stipulated that the term of the committee and its chairman shall conclude upon the completion of the special licensure examination;
- NOW, THEREFORE, BE IT RESOLVED that the board hereby approves and endorses the creation of the SPLE Committee (also known as the Committee on Graduate Auxiliary), which will be headed by a chairman;
- FURTHER RESOLVED that the chairman of the SPLE Committee shall be a member of the Board of Directors and will be selected by the executive board of the **UAP** Qatar chapter;
- FURTHER RESOLVED that the chairman of the SPLE Committee shall have the primary function of leading the review program and may gather a faculty of volunteers and mentors to facilitate the review sessions;
- FURTHER RESOLVED that the faculty members, mentors and committee members participating in the program shall be required to sign a commitment form, completing the program and affirming their dedication to fulfilling their selfless service without any expectation of compensation;
- FURTHER RESOLVED that the working committee will comprise newly passed architects who benefited from the program that are appointed by the chairman;
- FURTHER RESOLVED that the chairman of the SPLE Committee shall also serve as the coordinator of the UAP Qatar chapter and shall collaborate with the Philippine Professional Organization Qatar (PPO-Q);
